

General Terms and Conditions of booking

For the 2019 Pershore Plum Festival Fayre Day Food Village

Stallholders are advised to carefully read the following terms and conditions of stall hire prior to completing their application. They should also retain the copy of the terms and conditions for their future reference.

1. Applications for bookings will be taken for the Pershore Plum Festival Fayre Day Food Village occurring on Bank Holiday Sunday 25 and Monday 26 August 2019.
2. The full stall fee as outlined in the application pack is payable no later than Friday 28 June 2019, if you have been successful.
3. Upon an official offer of a pitch, acceptance is confirmed once payment is received. Cheques to be made payable to Pershore Plum Festival. This cheque will be banked by the Pershore Plum Festival upon acceptance of the stall. No post-dated cheques will be accepted. The application form is not valid unless completed in full and signed. By signing the application form you agree to comply with these conditions. BACS payable is possible if requested.
4. In the event of a cancellation, we regret refunds will not be given for bookings cancelled by exhibitors after Friday 26 July 2019. 50% of the booking fee will be returned if cancellation is made before this date. Any cancellations need to be received in writing by the Pershore Plum Festival.
5. All exhibitors must possess Public Liability Insurance cover/Food Safety certificates and must produce documentary evidence to that effect, this must be sent with the application or by Friday 16 August 2019 at the latest.
6. All applications for bookings will be considered and will be accepted entirely at the discretion of the Pershore Plum Festival Trading committee whose decision is final.
7. Stallholders are responsible for provision of all health and safety including fire and/or food safety standards where appropriate.
8. Stallholders must have their stalls set up and manned at all times during the opening hours which are 9.30am – 5pm. Stalls must be set up by the time the Fayre opens and must not be dismantled before the Fayre closes.
9. Stallholders may only set up during the morning. All vehicles must be moved to the Exhibitors' car park immediately after unloading.
10. Access for vehicles is available at set-up times between 7.00am and 9.30am and break down of stalls after 5.00pm. VEHICULAR ACCESS IS NOT AVAILABLE AT ANY OTHER TIME.
11. Exhibitor toilets and hand wash facilities are available at the Public Toilets situated on Abbey Park.
12. Facilities on site will be available for disposal of rubbish.
13. It is important that a good mix of catering is provided. The Pershore Plum Festival committee will allocate appropriate pitch positions at its discretion.
14. We will avoid any duplication of offering based on the stated products sold – therefore, please be accurate.
15. Services offered, articles sold and any vehicles brought into the Fayre area are at the risk of the stallholder. In particular the stallholder is at all times responsible for the safety of all items sold and/or held at the stall. The Pershore Plum Festival cannot accept liability for any damage to or loss of any items howsoever caused.
16. Any equipment used for cooking/heating must be placed in a position which is not accessible by the public, particularly children. It must also be placed on a stable surface in a position which does not present a risk of injury to stallholders, their staff or anyone involved in the operation of the event.
17. All stallholders must comply with directions and instructions issued by the Pershore Plum Festival and the official stewards. Failure to do so may result in the removal from the event.
18. Pitch space will be provided based on that requested within the application form and subsequently paid for. Additional space required which is not paid for, will be rejected and may terminate your right to trade at the festival without refunds.
